MATTERS FROM STAFF:

Cypress Street area pedestrian access update. Staff prepared a detailed Sidewalk Access Study. It was determined that there were (3) homes that encroached into the right of way. Staff will send letters to those (3) residents to remove the fence and/or landscaping that obstructs the path of travel.

Street counts have been received and a neighborhood meeting will be scheduled in June to receive public input regarding the street closures and it will be placed on the July 02, 2019.

Commissioner Kiisk-Mohr will meet with staff prior to agendizing any public safety issues and speed reduction policies.
